# **Fairfield Union Local School District** Operational Plans for Athletics in the Fall of 2020

#### Fairfield Union High School Gymnasium

- Home spectators will enter the front entrance and the cafeteria entrance of the building for all athletic events. Visiting spectators will enter through the student parking lot doors. To allow for one-way traffic, home spectators will enter and exit the gym through the cafeteria. Visiting spectators will enter the gym through the gym doors in the Vocational-Agriculture wing of the building. (See attached map, which will be mailed to visiting schools)
- Restrooms located near each gym entrance will be used to further promote social distancing between the different communities in attendance.
- All spectators, including students in grades K-12, will be required to wear facial coverings at all times. Spectators meeting one of the approved exceptions to the ODH order requiring masks will need to notify gate workers or the Compliance Officer at the game.
- > Athletes not actively involved in the game contest will wear face coverings at all times and will be socially distanced in the bench seating area.
- ➤ Hand sanitizer will be available in both bench areas, the scorer's table, and common areas including, but not limited to, building entrances, concession stands, and ticket
- Schools will be required to submit a pass list for each game. Each player will be limited to 2 guests on the pass list. All tickets will be \$5, and spectators must have correct change.
- Capacity will be capped at 15% of our fixed seating (130 spectators).
- > Signs promoting social distancing and proper personal hygiene will be posted throughout the venue. Public address announcements will be made throughout contests addressing these items as well.
- Guidelines from the Ohio Department of Health, the Fairfield Department of Health and the Ohio High School Athletic Association will be strictly enforced.

## <u>Falcon Stadium at Fairfield Union Local School District – Varsity Field:</u>

- Specific, separate gates at the stadium will be designated for home and visiting spectators. There will be a strict "no re-entry" policy in place. (See attached map)
- ➤ All spectators, including students in grades K-12, will be required to wear facial coverings at all times. Spectators meeting one of the approved exceptions to the ODH order requiring masks will need to notify gate workers or the Compliance Officer at the game.
- > Spectators will be permitted to stand in areas inside the stadium as long as social distancing requirements are followed.
- Athletes not actively involved in the game contest will wear face coverings at all times and will be socially distanced in the bench seating area.
- Hand sanitizer/soap will be available in both bench areas, the press box, and common areas including, but not limited to, concession stands, restrooms and ticket gates.
- One restroom location will be used for spectators. Participating teams will have access to separate restrooms.
- Schools will be required to submit a pass list for each game. Each football player, musician in the band, and cheerleader will be limited to 2 guests on the pass list. Soccer players will be limited to 4 guests on the pass list. All tickets will be \$5, and spectators must have correct change. Fairfield Union is seeking a variance to allow for 2 additional family members for Senior students only (total of 4 guests). Fairfield Union will maintain social distancing utilizing the stadium fence line and open fields surrounding the field (see the attached map). There would be 94 additional guests as a result of the variance, and we do believe there is more than enough room to accommodate the additional guests.
- Capacity will be capped at 15% of our fixed seating (450 guests 270 home spectators / 130 visitors spectators / 50 individuals for administrative functions officials, concessions, gate workers, etc...). Capacity would be 554 guests with the variance.
- Signs promoting social distancing and proper personal hygiene will be posted throughout the venue. Public address announcements will be made throughout contests addressing these items as well.
- > Guidelines from the Ohio Department of Health, the Fairfield Department of Health and the Ohio High School Athletic Association will be strictly enforced.


## <u>Falcon Stadium at Fairfield Union Local School District – Junior Varsity Field / Land Lab:</u>

- Specific, separate gates at the stadium will be designated for home and visiting spectators. There will be a strict "no re-entry" policy in place. (See attached map)
- ➤ All spectators, including students in grades K-12, will be required to wear facial coverings at all times. Spectators meeting one of the approved exceptions to the ODH order requiring masks will need to notify gate workers or the Compliance Officer at the game.
- Athletes not actively involved in the game contest will wear face coverings at all times and will be socially distanced in the bench seating area.
- Hand sanitizer/soap will be available in both bench areas, the press box, and common areas including, but not limited to, concession stands, restrooms and ticket gates.
- ➤ One restroom location will be used for spectators. Participating teams will have access to separate restrooms.
- > Schools will be required to submit a pass list for each game. Each football player, soccer player, cross country runner and cheerleader will be limited to 2 guests on the pass list.
- Capacity will be capped at 15% of our fixed seating (40 spectators). Due to the large, open areas surrounding the field, which is adjacent to our land lab, we are requesting a variance to allow for 2 family members for each athlete. Social distancing would be maintained by marking off 6 foot "pods" in which members of the same household could sit in lawn chairs. Cross country meets are held on our land lab. (See attached map)
- ➤ Signs promoting social distancing and proper personal hygiene will be posted throughout the venue. Public address announcements will be made throughout contests addressing these items as well.
- ➤ Guidelines from the Ohio Department of Health, the Fairfield Department of Health and the Ohio High School Athletic Association will be strictly enforced.
