



## Title 1 School-Parent Compact

- Encourage positive attitudes about school and support the school policies.
- Encourage my child to get enough sleep and eat nutritiously.
- Establish with my child a place to study and read daily.
- Participate in decisions relating to my child's education.
- Participate in my child's education, when possible, through volunteering, attending school functions, or serving on committees.

**School Responsibilities:** We, as classroom teachers, understand the importance of the school experience to every student and our position as a teacher and a role model. We will promote student learning in the following ways:

- Provide and deliver high quality curriculum and instruction in a supportive and effective learning environment, in which parents are welcome partners, to enable your child to meet the State's student academic standards.
- Provide parents with opportunities to volunteer and participate in their child's class.
- Be aware of your child's needs.
- Communicate with you about your child's progress frequently with progress and report cards.
- Motivate and encourage your child to practice academics at school and at home.
- Hold parent-teacher conferences.
- Provide materials and/or ideas for home to enhance literacy, numeracy or other academic subjects.
