- Step 1- You are required to purchase the \$10 parking permit through Local Level Events sales portal.**
Step 2- After August 8 - The student must present this completed application and their driver's license to the cashier when picking up their hang tag. Your assigned parking spot will be issued by the office staff.
Note: This parking application is not complete until payment has been made on Local Level and your hang tag is displayed in the vehicle.

PLEASE NOTE:

- **Students are required to notify the office if they drive a vehicle that is not registered on their permit.**
- Irresponsible driving on the school lot, not yielding to school bus traffic, parking in other parking spaces, chronic absenteeism or tardiness, and/or a disciplinary record may revoke this permit.
- The parking permit shall be located on the backside of the rearview mirror of each vehicle at all times.
- The car only zones will be enforced. If your primary vehicle is a truck, you must park in the truck zones.
- Once school starts, students should park *only in their assigned spot.*
- Students may not move vehicles during school hours.
- No vehicle will be permitted on the school lot without the permit after September 12, 2024.
- REPLACEMENT TAGS WILL COST \$1.00.

2024-2025 Parking Permit Presale Details and Maps

Parking permit pre-sales will open at 9:00 a.m. on the following schedule:

Seniors – July 24 (Student ID# Required)

Seniors and Juniors – July 25 (Student ID# Required)

All grades – July 26 and beyond (No ID# Required)

Process to obtain a parking pass:

- Students will choose two preferred parking zones. Zones are noted on the parking map and are as follows:
 Zone 1 – Spots 1-36 (**cars only**)
 Zone 2 – Spots 37-141 (center of the main lot – **cars only**)
 Zone 3 – Spots 145-164 (**trucks only** – back row)
 Zone 4 – Spots 165-195 (**trucks only** – front row)
- The car only zones will be enforced. If your primary vehicle is a truck, you must park in the truck zones.
- Each purchase on local level is assigned a ticket # - **THIS IS NOT YOUR PARKING SPOT**
- Parking assignments will be issued by the office staff according to your Local Level Ticket # and your zone preference. All sales will be conducted online.
- Visit the Local Level Events site through this link to start the permit process:
Parking Permit Sales-Local Level Events The link will not be live until July 24 at 9:00 a.m.
- Each student is permitted to purchase ONE parking permit through the Local Level Online Sales System. For the first two days of the sale, the student will use their student ID (lunch number) to purchase a permit.
- You must have your car license plate number, your driver's license number* and your insurance information to enter into the Local Level System. Be sure to have it on hand when you start the process.**
- Students who drive trucks must choose a designated spot for trucks or they will be reassigned to the next available truck location.

***Student must possess a valid driver's license. (No student may be issued a parking permit on their learner's permit.)**

- Once school starts, students should park only in their assigned spot.
- To be issued their validated parking hang tag, the student must present the following items to the cashier:
 - A completed Parking Permit Application
 - Their driver's license
- Student must present this documentation to the cashier no later than **September 11** or the student will forfeit their priority parking privilege and will be reassigned to a parking spot outside of Zones 1-4. **No vehicle will be permitted to park on school property without a permit & hangtag after September 12, 2024.**
